Exclusion of Liability, Waiver of Legal Rights and Assumption of Risk

EACH INDIVIDUAL COMPETITOR MUST SIGN THIS WAIVER

In consideration of my use of the Squamish Windsports Park (particularly described in the District of Squamish Training Dyke-Windsurfer's Permit of Occupation, Bylaw #1069, 1989), operated by the Squamish Windsports Society (henceforth the "Society"); particularly pertaining to, but not exclusively, the 2010 Kiteboarding Race Summer Series, hosted and operated by the Society.

I, _____, **HEREBY AGREE AS FOLLOWS:**

1. I ACKNOWLEDGE THAT kiteboarding is an action sport and a recreational activity involving travel in three dimensions and as such, these activities are subject to mishap and even injury to participants. I understand I may suffer a broken limb, paralysis or other serious injury, or fatal injury while participating in the sport of kiteboarding at the Squamish Windsports Park. In addition, I am aware that the specific aspects of kiteboarding pertaining to kiteboard racing involve by nature additional concerns including, but not limited to, high speeds, adverse environmental conditions, and close proximity to other riders, navigational devices and obstacles.

2. TO ASSUME ALL RISKS of personal injury, death or property loss or damage resulting from any cause whatsoever, including but not limited to the inherent risks of kiteboarding, kiteboard racing, course racing, kiteboarding equipment, the use of the retrieval vessel and its attendants, collision with natural or man-made objects or other windsurfers, kiteboarders, vessels and vehicles, travel within or beyond the boundaries, or negligence on the part of the District of Squamish, its officers and servants, Her Majesty the Queen, Her officers and servants, the Society, and its directors, its officers, employees, agents, representatives, race committee, race directors and volunteers.

3. TO RELEASE, HOLD HARMLESS AND INDEMNIFY the District of Squamish, its officers and servants, the Society, its directors, officers, employee, agents, representatives, race committee, race directors and volunteers and their heirs, administrators, servants, agents, successors, and assigns of and from any and all actions, claims, liabilities, demands, damages, interest, costs, expenses, and compensation of whatsoever kind and howsoever arising whether known or unknown, and which I have now or at any time hereafter, can shall or may have in any way arising from or in connection with my use of the Squamish Windsports Park, and or the Squamish Kiteboard Race Series.

4. I WILL NOT SUE OR MAKE A CLAIM against the District of Squamish, its officers and servants, Her Majesty the Queen, Her officers and servants, the Society, its directors, officers, employees, agents, representatives, race committee, race directors and volunteers and their heirs, administrators, servants, agents, successors, and assigns for injury, death, damages, or other losses sustained as a result of my participation in any event on, or in connection with, or use of, the Squamish Windsports Park.
