EXCLUSION OF LIABILITY AND ASSUMPTION OF RISK (MANDATORY for all members single or family)

TO RELEASE, HOLD HARMLESS AND INDEMNIFY the District of Squamish, its officers and servants, the Society, its directors, officers, employees, agents, representatives and volunteers and their heirs, administrators, executors, servants, agents, successors, and assigns of and from any and all actions claims, demands, damages, interest, costs, expenses, and compensation of whatsoever kind and howsoever arising, whether known or unknown, and which I have now or at any time hereafter, can shall or may have in any way or arising from or in connection with my use of the Squamish Windsurfing Park.
